SIA "SIGULDAS SPORTA SERVISS" SIGULDA SPORTS CENTRE INTERNAL PROCEDURE REGULATIONS

I GENERAL RULES:

1. INTRODUCTION

- 1.1. The present Regulations of the Sigulda Municipality Capital Company SIA "Siguldas Sporta serviss" (Reg.No. 40003411141), the Sigulda Sports Centre "Siguldas Sporta centrs" (hereinafter – SSC), located at Ata Kronvalda iela 7A, Sigulda, LV-2150 (hereinafter – the Regulations), shall govern the use of the Swimming Pool, Water Amusement Park, Gym, TRX, Power Gym, Sports Hall, Athletics Zone and other premises and equipment available at the SSC, the use and operation of the property, as well as the rights and obligations of any visitor (including the lessee, representatives of legal bodies and educational institutions, employees, school staff and students, athletes, spectators of competitions or classes, participants, parents, guardians, representatives, authorised persons, etc.) (hereinafter referred to as "Visitor").
- 1.2. It is the responsibility of each Visitor to carefully read and observe these Regulations before visiting the SCC. The Regulations are available at the SSC Customer Service and on the website www.siguldassports.lv/lv/noteikumi/ and are also displayed on the information board in the SSC facility.
- 1.3. Organisers of sporting and cultural events and/or tenants of SSC premises may impose their own rules and requirements which, in addition to these Regulations, shall be complied with by SSC Visitors. In the event of any inconsistency between the Regulations, these Regulations shall be deemed to prevail.
- 1.4. These Regulations are intended to ensure the safety and orderly conduct of SSC Visitors and the successful operation of SSC. SSC grants permission for Visitors to use the Sports facility only in accordance with these Regulations.
- 1.5. The legal obligations between SSC and the Visitor are governed by these Regulations. The purchase of a Service (confirmed by a receipt, ticket, subscription, membership pass, contract, gift card, online purchase or otherwise, legally obtained SSC approval or permission to use the SSC) confirms that the Visitor has read and agrees to be bound by these Regulations.
- 1.6. A Visitor's right to use the SSC shall cease if the time and date specified on the ticket, gift card, pass or contract expires or if the person's ticket or pass is cancelled because of a failure to comply with these Regulations.
- 1.7. In the event of non-compliance with the Regulations, the SSC staff, or people responsible for events, classes have the right to deny service, refuse entry and/or expel visitors from the SSC premises, cancel tickets, cancel passes, ban the use of the SSC and/or call security guards or state or municipal police officers. In such case, the Visitor shall not be refunded the entry fee paid.

2. VISITING POLICY

- 2.1. When purchasing a membership pass or wishing to purchase a service, the Visitor must present a valid personal identification document (passport, ID card) identifying the person and/or a document validating the discount.
- 2.2. The Visitor may purchase a gift card for SSC services for themselves or for other people. The validity period of the gift card is 6 (six) months from the date of purchase. The gift card cannot be used to pay for purchases in the Sports Centre café. The gift card may be extended once for one month within two months after the expiry date at a surcharge of EUR 5.00 (five euro and 00 cents).
- 2.3. SSC Customer Service Officers have the right to suspend the access of visitors to the swimming pool area or the Water Amusement Park if the number of visitors exceeds the permitted limit.
- 2.4. Visitors under the age of 18 (eighteen) years shall present an identity document (passport, identification card or school ID) when purchasing a ticket or membership pass.
- 2.5. Children up to and including the age of 13 (thirteen) years may use the swimming pools, Water Amusement Park, Gym, TRX Gym, Power Gyms, and other SSC premises only under the direct supervision of an adult (incl. parents, legal guardians, coaches, instructors, teachers, hereinafter referred to as "adult"). Children under the age of 13 years (excluding the Water Amusement Park) may enter the SSC premises only for the purpose of using the services or as a visitor to SSC events, only under the direct supervision of an adult and in accordance with the entrance fee set out in the SSC price list. The adult assumes full responsibility for observing these Regulations and bringing them to the child's attention, the child's health condition and the child's behaviour during use of and visit to the SCC. The adult must be at least 18 (eighteen) years of age and with authorization from the child's parent or guardian.
- 2.6. Children from the age of 14 (fourteen) until the age of majority may visit swimming pools, Water Amusement Park, Gym, TRX Gym, Power Gym without the presence of an adult, if one of the parents or legal guardians has filled in and signed the "Parental Permission" form, assuming care and responsibility for their child, child's health condition, behaviour, as well as compliance with these Regulations or if the child visits the above mentioned sports areas as part of educational process accompanied by an authorised adult (e.g. teacher, coach).
- 2.7. Mentally disabled individuals may visit the SSC only accompanied by an adult companion who assumes responsibility for the individual's skills, health, safety and ensures that the individual is made aware of the Regulations and adheres to them. The accompanying person shall visit the SSC free of charge.
- 2.8. Special needs individuals who require assistance before, during or after sports may attend the SSC with an adult companion. The accompanying person shall visit the SSC free of charge.
- 2.9. A Visitor is entitled to use the services provided by the SSC if the Visitor has received an electronic wristband of a certain colour:
 - 2.9.1. a red wristband – the Visitor has purchased a one-time pass to the Water Amusement Park,
 - 2.9.2. a yellow wristband – the Visitor has purchased a one-time pass or a membership pass to the swimming pools,
 - 2.9.3. a blue wristband – the Visitor has purchased a one-time pass to the Water Amusement Park and Swimming pools,
 - 2.9.4. a black wristband – the Visitor has purchased a one-time pass or a membership pass to the Power Gym,
 - 2.9.5. a green wristband – the Visitor has purchased a one-time pass for group classes in the TRX, Gym or Athletics Lane Zone.

- 2.10. A Visitor shall be credited with 120 (one hundred and twenty) minutes of visiting time upon receipt of a red electronic wristband and registration at the entrance. After visiting the Water Amusement Park, the Visitor must hand in the wristband at the exit to determine the time spent. The excess time, as well as the products purchased in the Water Amusement Park café, if any, shall be billed.
- 2.11. A Visitor shall be credited with 90 (ninety) minutes of visiting time upon receipt of a yellow electronic wristband and registration at the entrance. After visiting the Swimming pool zone, the visitor must hand in the wristband at the exit to determine the time spent. The excess time shall be billed.
- 2.12. A Visitor shall be credited with 120 (one hundred and twenty) minutes of visiting time upon receipt of a blue electronic wristband and registration at the entrance. After visiting the Water Amusement Park or the Swimming pools, the visitor must register again at the exit to determine the time spent. The excess time, as well as purchases made in the Water Amusement Park café, if any, shall be billed.
- 2.13. A Visitor shall be credited with 90 (ninety) minutes of visiting time upon receipt of a black electronic wristband and its registration at the entrance. After visiting the Power Gym, the visitor must hand in the wristband at the exit in order to determine the time spent.
- 2.14. A visitor with special needs and their accompanying person shall not be subject to any visiting time limit when receiving an electronic wristband and registering for the service.
- 2.15. For excess time limit provided for in Paragraphs 2.10, 2.11, 2.12, 2.13 and 2.14 of the Regulations, the Visitor shall pay an additional fee according to the price list established by SIA "Siguldā Sporta Serviss", which sets the cost of each additional hour for a specific type of visit.
- 2.16. Should the Visitor lose or intentionally damage the electronic wristband, the Visitor shall pay a replacement fee of EUR 7.00 (seven euros and 00 cents).
- 2.17. The SSC Swimming Pool, Water Park, Power Gym, Exercise Gym and TRX Gyms may only be accessed with electronic wristbands, which are configured according to the type of visit and are issued individually.
- 2.18. A Visitor may obtain information about their locker number, time spent, and amount of money spent on purchases from the Water Amusement Park café in the changing rooms, Swimming pool zone and Water Amusement Park at the terminal.
- 2.19. Outerwear and street shoes must be left in the wardrobe before entering the changing rooms. SIA "Siguldā Sporta serviss" is not responsible for personal belongings left in the wardrobe.
- 2.20. A Visitor must wear clean change shoes whilst in the changing rooms.
- 2.21. The locker can be opened and closed by means of an electronic wristband. It is the Visitor's responsibility to check the security of their locker when it is locked. The Visitor must leave the locker open at the end of the visit.
- 2.22. A Visitor must be aware that the floors of the showers and changing rooms may be wet and slippery.
- 2.23. A Visitor must assess their own and their child's physical abilities and health before visiting the SSC and using the selected service. The Visitor is obliged to inform the SSC in writing of their own and their child's health condition if there is a reasonable risk to their health or life from using the selected SSC service.
- 2.24. If, during a visit to the SSC, the Visitor's health deteriorates, the Visitor should immediately contact a SSC staff member who will, if necessary, call for emergency medical assistance.
- 2.25. SSC staff have the right to request to see the contents of the Visitor's bag – for security reasons.

- 2.26. A Visitor has the right to make a written claim, complaint, or recommendation about any incident on SSC premises. A QR code with the claim form is displayed in the Information Centre and the claim form is available at the SSC Customer Service Officers.
- 2.27. The updated opening hours of the SSC are published and regularly revised on the website <https://www.siguldassports.lv/en/>
- 2.28. In the event of unforeseen circumstances (e.g. damage to utilities, power outages, national epidemiological safety requirements, etc.) which prevent or substantially impede the ability to provide a safe and quality service to Visitors, SSC shall have the right, without prior notice, to suspend the provision of all or part of the services to Visitors of SSC. In the event of emergency circumstances, SSC shall promptly publish a relevant notice on SSC's website and/or Facebook, Instagram accounts, as well as display it in SSC's Customer Service Centre. If the emergency conditions persist for more than 1 (one) day, the validity periods of the purchased membership passes shall be extended in accordance with the period during which the use of the service by SSC Visitors was restricted.

3. FORBIDDEN

- 3.1. It is forbidden to enter the SSC by bicycle, roller skates or any other mobility means, except for baby strollers and wheelchairs for people with disabilities.
- 3.2. It is forbidden to bring weapons, explosives, flammable substances, poisonous substances, alcoholic beverages, narcotic or toxic substances, glass and tin containers and other objects that may obstruct the conduct of competitions and other events, the quality of the service provided and endanger the health, safety, and life of people.
- 3.3. Smoking, any kind of cigarettes, including electronic, Salt Switch, disposable vapes, IQOS, etc., use of alcoholic beverages, narcotic and toxic substances on the premises of the SSC is forbidden.
- 3.4. It is forbidden to use any services under the influence of alcohol, drugs, or other intoxicating substances, which affects one's behaviour and endangers one's safety or the safety of others and the ability to fully use the services of the SSC. The staff member has the right to request to leave the SSC premises and, in case of non-compliance, to call the authorities.
- 3.5. It is forbidden to damage or move information signs or other objects of public use (including SSC premises, equipment, inventory).
- 3.6. It is forbidden to damage or alter in any way the equipment, devices, inventory of the SSC, to use them for any purpose other than their intended use and to install any structures without the prior approval of the SSC administration.
- 3.7. It is forbidden to use the structures, their elements, equipment, installations and their elements in the premises and territory of the SSC in a way that is inappropriate for their intended use and load-bearing capacity (including hanging from basketball hoops, soccer goals).
- 3.8. The electronic wristband must not be transferred to third parties.
- 3.9. During the visit to the SSC, it is forbidden to create sounds or sound effects that could disturb the SSC staff or other Visitors.
- 3.10. It is forbidden to abuse SSC staff and SSC Visitors or participants of competitions, other types of events, referees morally or physically.
- 3.11. It is forbidden to be disrespectful or aggressive towards SSC employees and SSC Visitors, participants of competitions or other types of events, referees.
- 3.12. It is forbidden to litter the SSC premises and territory.
- 3.13. It is forbidden to enter the SSC with animals.

- 3.14. It is forbidden to conduct commercial activities and/or display advertising materials in the premises and territory of the SSC without prior approval of the SSC administration.
- 3.15. Visitors without an electronic wristband and in outerwear, street shoes are forbidden to enter and stay in the changing rooms of the SSC Water Zone, Swimming Pool Zone, Water Amusement Park, Power Gym, Exercise Gym or TRX Gym or Athletics Zone.
- 3.16. Visitors are forbidden to visit the SSC with acute symptoms of illness (high temperature, fever), conjunctivitis, skin or other contagious diseases, open wounds or bandages that may endanger the safety of other visitors.
- 3.17. Children under the age of 12 (twelve) years (inclusive) must not be left without adult supervision.
- 3.18. It is forbidden to take photographs, film or make audio recordings in the SSC Swimming pools, Water Amusement Park, changing rooms, Power Gym, Exercise Gym, TRX Gym, Sports Hall and Athletics Zone without written consent of the administration of SIA "Siguldass Sporta Serviss".
- 3.19. It is forbidden to use the evacuation exit door to enter and/or exit the SSC unless an emergency has been identified and immediate evacuation of people from the SSC premises is required.
- 3.20. In the event that a Visitor is found to have purchased one service but instead uses another SSC service without paying for it, the Visitor shall be obliged to pay for the service they actually used in accordance with the price list established by the SSC. If the Visitor avoids paying for the services they actually used, the Visitor shall be evicted from the SSC without reimbursement of the service that was effectively purchased.
- 3.21. It is forbidden to engage in the distribution, advertising or sale of dietary supplements, dietetic food, and sports food, except with the permission of the SSC administration.
- 3.22. Any Visitor who fails to comply with these Regulations, warning signs, notices, instructions of SSC staff, Sports Coaches, Sports Specialist (lifeguard) or the Competition Organiser, thereby causing harm to their health, endangering their own and/or other Visitors' health, life or interfering with other Visitors' use of the Service may be evicted from the SSC without refund of the service fee paid. For repeated failure to comply with the requirements, the administration of SIA "Siguldass Sporta Serviss" has the right to cancel the Visitor's membership or admission card without refunding the value of the membership or admission fee.

4. RESPONSIBILITY

- 4.1. A Visitor is responsible for reading and complying with these Regulations, as well as for their health condition, physical fitness and skills while attending classes, competitions, etc. at the SSC.
- 4.2. The parents or guardians of minors shall be responsible for bringing minors into compliance with these Regulations as well as for the behaviour, safety, and health of minors, in accordance with the procedure established by law.
- 4.3. During sports classes, camps or other events conducted by schools, kindergartens, sports schools, associations, etc., coaches, teachers, tutors, as well as other persons accompanying, supervising minors shall be responsible for the safety, health, and actions of minors. The person in charge must acquaint the students with these Regulations before the start of the lesson or event and must ensure that they are complied with during the lesson, class, camp, or other event.
- 4.4. The organiser of the competition/event is responsible for its conduct and safety. If, during the competition/event, conditions arise which may endanger participants and/or visitors, the

organiser is obliged to inform SSC staff immediately and to suspend or stop the competition/event until the danger has been eliminated.

- 4.5. A Visitor is responsible for their own personal belongings and the SSC is not responsible for lost or abandoned belongings and will not take custody of them. Taking into account that SIA "Siguldass Sporta Serviss" does not accept Visitor's belongings for storage, but only provides the Visitor with the use of the storage room and/or changing room lockers, the administration of SIA "Siguldass Sporta Serviss" shall not be held responsible for Visitor's belongings left in the storage room and/or changing room lockers.
- 4.6. A Visitor shall be liable for any damages caused to SIA "Siguldass Sporta Serviss" or third parties as a result of their actions. If the Visitor does not comply with and violates these Regulations, as well as does not comply with the instructions of the SSC employee, sports coach, or sports specialist (lifeguard), thereby causing damage to their health, endangering their own or other Visitors' health or life, suffering material damage and/or causing any kind of damage to another Visitor – SIA "Siguldass Sporta Serviss" shall not be held liable.

5. ADDITIONAL RULES FOR SPORTS ACTIVITIES

- 5.1. Sports activities in all SSC premises shall be conducted under the guidance and supervision of a qualified coach, sports instructor, or other responsible person.
- 5.2. Advance registration for sports activities is required.
- 5.3. The coach, sports instructor or other responsible person conducting regular classes or renting premises in the SSC shall be responsible for the keys to the premises. In one-off premises rental situations, the responsible person shall sign for the receipt and handing over of the keys. The penalty for a lost key to the premises shall be EUR 30,00 (thirty euro and 00 cents).
- 5.4. It is forbidden to wear cleated shoes outside the special athletics surface in the athletics zone. The penalty for non-compliance with this rule is EUR 1200.00 (one thousand two hundred euro and 00 cents), the responsible person being the coach or instructor.
- 5.5. Sports participants are allowed to stay in the changing rooms of the SSC for 15 minutes before and 15 minutes after the training.
- 5.6. The changing rooms must be left clean and tidy after the sports practice.
- 5.7. During lessons and competitions, each individual is responsible for their own personal equipment, safety, and health.
- 5.8. A Visitor may be informed by phone (call or text message) of any unforeseeable changes to the classes for which they are registered.

6. ADDITIONAL RULES FOR VISITORS TO THE SWIMMING POOL ZONE AND THE WATER AMUSEMENT PARK

- 6.1. Visitors must strictly observe the time, place, or validity period of their membership pass. Organised swimming lessons, as well as practice or lessons for groups using the separate lanes or the small swimming pool, shall take place according to a pre-agreed schedule. At the end of the swimming session or lesson, the Visitor must leave the swimming pool zone immediately.
- 6.2. A Visitor is reminded that the floors of the showers and changing rooms may be wet and slippery.
- 6.3. When using hair drying equipment (hair dryers), it is forbidden to use them with wet or damp hands and to keep a distance between the hair and the hair drying equipment when using them.
- 6.4. A Visitor is responsible for personal hygiene.

- 6.5. A Visitor may wear flip-flops, boot swabs or bare foot, swimming trunks and swimsuits, in the Swimming Pool Zone or the Water Amusement Zone. Beach shorts are not allowed.
- 6.6. Swimming caps must be worn in the Swimming Pool Zone.
- 6.7. A Visitor is obliged to observe the depth marks indicated in the swimming pools.
- 6.8. Children under the age of 3 (three) years (inclusive) are only allowed to visit the Swimming Pool Zone or the Water Amusement Park wearing waterproof diapers.
- 6.9. It is the visitor's responsibility to assess and be responsible for their own health condition and to choose the type of sauna, duration of stay in the saunas, duration of stay in the whirlpools and hydro-massage pool accordingly. If you are taking medication (antibiotics, antidepressants, diuretics, etc.), you should consult a doctor and follow the instructions posted outside the saunas.
- 6.10. Before and after visiting the Water Zone, as well as every visit to the sauna, the Visitor must take a shower.
- 6.11. In a sauna with wooden decoration, you must use your own towels.
- 6.12. Before visiting the Water Amusement Park, you must assess your body's capabilities and not stay in the sauna for more than 10 minutes if:
 - 6.13. you have been physically exhausted for a long time;
 - 6.14. you have had sleep disturbances;
 - 6.15. you have consumed alcohol or other intoxicating substances within the previous day;
 - 6.16. if you have health problems (especially cardiovascular diseases);
 - 6.17. it is the first time that this type of sauna has been used. ^LSEP
 - 6.18. Immediately stop using the sauna if any discomfort occurs.
- 6.19. While in the sauna, a Visitor must refrain from any action that may endanger their own life, health, or safety or that of others.
- 6.20. When in the Steam sauna, visitors must not stand on either side of the door where the steam supply to the sauna room is located.
- 6.21. It is forbidden to touch the heating devices in the sauna or to place any objects or clothing on them.
- 6.22. It is forbidden to use sauna brooms, body cosmetics (honey, coffee grounds, clay, etc.) in saunas.
- 6.23. It is forbidden to pour water or other liquids on the heating elements of the sauna.
- 6.24. No food, any drinks in glass containers, alcoholic beverages, or other intoxicating substances.
- 6.25. No chewing gums.
- 6.26. No spitting on the floor, walls or in the water.
- 6.27. No natural urges outside the designated areas.
- 6.28. No shouting, whistling, running or unnecessarily calling for help in order not to mislead SSC staff.
- 6.29. It is forbidden to be present without a swimsuit or swimming trunks.
- 6.30. Jumping into swimming pools from their sides and starting platform or diving without assessing one's physical condition and swimming skills is forbidden.
- 6.31. No climbing on the windowsills, sliprails, or edges of slides, or jumping into any body of water.
- 6.32. No sitting or stepping on the pool lane barriers / wave dampers.
- 6.33. It is forbidden to wear a special wetsuit, mono fins or to use diving equipment unless written permission has been obtained from the administration.
- 6.34. It is forbidden to use slides and other attractions with rings, watches, earrings, chains, etc., which may cause injury to oneself and other visitors.

- 6.35. It is forbidden to use the counter currents and cascades in the hydromassage pool for pregnant women.
- 6.36. No children under the age of 12 (twelve) years (inclusive) may be left in the Swimming Pool or Water Amusement Park without adult or sports coach supervision.
- 6.37. The Swimming pool zone must be vacated no later than 15 (fifteen) minutes before the end of opening hours, and the shower and changing area no later than 5 (five) minutes before the end of opening hours.
- 6.38. The Water Amusement Park shall be vacated no later than 30 (thirty) minutes before the end of opening hours and the shower and changing area no later than 10 (ten) minutes before the end of opening hours.

7. ADDITIONAL REGULATIONS OF THE POWER GYM, EXERCISE GYM, TRX GYM, ATHLETICS ZONE AND SPORTS ZONE AND HALL

- 7.1. Minors under the age of 6 (six) years (inclusive) are not allowed to visit the SSC Power Gym, even if they are accompanied and supervised by an adult or a sports coach.
- 7.2. Minors from 7 (seven) to 13 (thirteen) years of age (inclusive) may visit the SSC Power Gym only in the presence and under the supervision of an adult or a sports coach. It is forbidden to leave children (7 to 13 years (inclusive)) without adult supervision (incl. coach).
- 7.3. Before using the SSC Power Gym equipment and gear, the Visitor must review the Regulations governing the use of the equipment and gear posted on the SSC premises or on the equipment or gear, and in case of any questions and doubts, shall not use the equipment and gear, but shall contact the responsible SSC staff for any necessary information.
- 7.4. Visitors shall use SSC equipment and gear only for its intended purpose and in accordance with the methods and procedures specified in the Regulations governing the use of such equipment and gear; they shall not use temporarily damaged equipment and gear.
- 7.5. The Visitor is informed and agrees that he/she shall work (exercise) in the Power Gym autonomously, choosing specific fitness equipment, tools, devices, as well as physical load based on their individual needs, personal characteristics, and effects on the body. SSC staff members may not be present in the SSC Power Gym, and the Visitor may work out in the Power Gym without the supervision of an SSC staff member.
- 7.6. Before each visit to the SSC, the Visitor is obliged to review the SSC evacuation plan, which is located at the entrance to the Power Gym.
- 7.7. A Visitor shall not interfere with other Visitors using the services of the SSC. Visitors who notice inappropriate behaviour by other Visitors that disturbs other Visitors from using the services or may endanger the safety and health of other Visitors shall inform the supervising SSC staff member.
- 7.8. Entry is permitted only in gym or change shoes, socks, or boot swabs.
- 7.9. Visitors are obliged to treat SSC sports equipment and devices with care.
- 7.10. Visitors shall use the equipment in the gym according to their physical fitness. SSC shall not be held liable for any injuries that may occur to a Visitor as a result of the use of inappropriate equipment.
- 7.11. Visitors are obliged to put away the equipment in the place provided for it after using it.
- 7.12. Visitors are obliged to clean the equipment and mats after use with the cleaning products provided.
- 7.13. Visitors are obliged to maintain order and tidiness and to dispose of rubbish only in the designated areas.

- 7.14. Visitors are obliged to observe the signs in the room and the instructions of the supervisors, instructors / coaches.
- 7.15. It is forbidden to use the Power Gym without a towel.
- 7.16. It is forbidden to throw dumbbells, weight bars, discs, and other equipment on the floor.
- 7.17. It is forbidden to walk barefoot and with bare upper body.
- 7.18. It is forbidden to voluntarily turn on, turn off or adjust – the music system, television, and ventilation devices.
- 7.19. It is forbidden to bring in food, any drinks in glass containers, alcoholic beverages, or other intoxicating substances.
- 7.20. No chewing gums.
- 7.21. No spitting on the floor or walls.
- 7.22. It is forbidden to wear cleated shoes outside the special athletics surface in the Athletics Zone.
- 7.23. It is forbidden to step on the sand pit cover in the Athletics Zone with cleated shoes.
- 7.24. If the fitness equipment is not in use between exercises, it is not permitted to stand on it or otherwise prevent other Visitors from using it.
- 7.25. The Power Gym must be vacated 15 (fifteen) minutes before the end of the working time, and the shower and changing area 5 (five) minutes before the end of the working time.
- 7.26. Only athletic coaches who have an agreement or contract with the SSC to that effect are allowed to conduct individual classes in the Power Gym.

8. PROCESSING OF PERSONAL DATA

- 8.1. - 8.3.
